Additionally, piping, valves, and instrumentation will be installed within the existing filter gallery and filter control room to provide a fully functional dual-media filter to match the City's existing filters.

The City reserves the right to waive any informality and to reject any and all proposals for any reason

determined to be in the best interest of the City, except for the purpose of evading the bid laws. If awarded, the project will be awarded to the lowest responsive and responsible bidder taking into consideration quality, performance and the time specified in the proposals (if required to be specified). Non-responsive bids will be rejected.

It is the policy of the City to award public building contracts without regard to race, religion, color, creed, national origin, sex, age or disabling condition.
